Specific Programme

Strategic Plan

- Multiannual maximum 4 years, adopted by means of an implementing act
- Will define the design of the multiannual WPs and call for proposals
- Main focus pillar II but also pillar III and widening actions
- Will contain:
 - Key strategic orientations for R&I support (expected impacts, cross-cluster issues and intervention areas covered)
 - Identification of European Partnerships and Missions (definition)
 - Areas for international cooperation,
 - Specific issues (balance between R&I, gender, SSH, ethics, dissemination and exploitation)



STRATEGIC PLANNING - timeline

- Commission Expert group "shadow" Strategic Configuration of the Horizon Europe Programme Committee appointment in May (?)
- Advisory boards for mission areas call for expression of interest (May?)
- First draft of the Strategic Plan (3 June)
- Online consultation (open globally) on the first draft (June)
- Second draft open for consultation during R&I Days (24-26 September)



STRATEGIC PLANNING - ERRIN's focus

A COLLABORATIVE APPROACH

- Quadruple helix focus on the wider regional development agenda and ecosystem thinking
- Regional innovation ecosystems as a crucial part of Horizon Europe

COHERENCE TO INCREASE IMPACT

- Place-based regional innovation ecosystems in Horizon Europe to better coordinate research and innovation priorities, practices — and funding — at all governance levels
- Synergies with other EU programmes



STRATEGIC PLANNING - ERRIN's focus

• Pillar III - European Innovation Ecosystems

- "The EU will in synergy with other Horizon Europe activities, including those of the EIC and EIT, and with the regional smart specialisation strategies."
- EIC and EIT complementarities and regional innovation ecosystems

• Pillar II - clusters

- Experiences of working in a collaborative systemic approach
- Climate, energy and mobility + Digital + Food and natural resources
- Opportunity to connect regional innovation ecosystems how?



STRATEGIC PLANNING - ERRIN's focus

Missions

- Potential to enhance policy coherence and encourage bottom-up solutions
- An opportunity to have less prescriptive calls and open doors for different solutions as well as new actors
- Possibility to advocate for specific missions (within a mission area)
- → Open questions for Commission speaker at MB meeting 7 May?
