New leading-edge research infrastructures in all fields of science and technology are needed by the European scientific community in order to remain at the forefront of the advancement of research, and to be able to help industry strengthen its base of knowledge and its technological knowhow. The Horizon 2020 INFRADEV calls (from 01 to 04) fund the feasibility and conceptual design studies, as well as the development and long-term sustainability of new pan-European research infrastructures in 5 thematic areas (energy, environment, health & food, physical science & engineering, social & cultural innovation). The event aims at giving an overview of the ESFRI Roadmap, presenting the calls (2019 and 2020), as well as assessing the interest of ERRIN members to develop a distributed research infrastructure.



On the policy side, the meeting will give the opportunity to know more about the initiative pushed by the Commission to develop a coherent approach on technological infrastructures aiming at granting European industry access to appropriate infrastructures to test, scale-up and diffuse cutting-edge Key Enabling Technologies (KETs).
