ROOM FOR IMPROVEMENT



The strategic challenges and objectives are **not** always clearly translated in specific calls and topics.



Low involvement of civil society (but improved over FP7). Need to **bring R&I closer to the public.**





5. Adopt a mission-oriented, impactfocused approach to address global challenges

Action: Set research and innovation missions that address global challenges and mobilise researchers, innovators and other stakeholders to realise them.

We have made progress in Horizon 2020 to focus resources in selected areas. But we still support too many different projects that disperse or fragment our funding.

We need to set our eyes on a specific target, and drive our scientific efforts towards reaching that target. And we need to be ambitious about it."





TOWARDS FP9: R&I MISSIONS

WORKING DEFINITION

Assignment given for a portfolio of R&I actions to achieve measurable results for a given impact within a set timeframe



The challenge-based, mission-oriented approach takes the strategic programming of Horizon 2020 a step further, notably building on the experience with focus areas.



Within the global challenges part of FP9, it will:

- set direction,
- maximise impact and
- better relate to citizens.





TOWARDS FP9: R&I MISSIONS



R&I actionable from the EU level;

- Transformative potential for science, technology, industry and/or society and systemic remit;
- Set direction towards an impact expected within a timeframe beyond individual topics or projects;
- Easy to communicate, to capture public imagination and to involve the public (co-design and co-creation);
 - Induce action across disciplines, sectors and policy departments





TOWARDS FP9: R&I MISSIONS

- Open to all actors in the R&I chain (e.g. cities...) providing for experimentation;
- Level of granularity or scope adapted to the challenge (accelerator or transformers);
- Implemented through non-prescriptive calls for proposals (including choice of instrument) leading to a portfolio of EU interventions;
- Possible to ascertain, measure and communicate extent of mission accomplishment within the appropriate timeframe;
- Steering and flexibility for success, tolerance for failure and unexpected spillovers
