## **EU MISSIONS**

Strong emphasis on the EU Missions as a key priority for ERRIN – combining both the place-based and ecosystem perspective >> One of the main two priorities of ERRIN

### Why are EU Missions so crucial for local and regional actors?


- Strong local and regional dimension (green deal missions)
- Societal & governance innovation essential (ecosystem approach)
- Mission calls encourage new stakeholders to work together Newcomers in Horizon calls
- Mission approach more and more integrated into local and regional policies (EU Missions Local Missions)

### Tangible benefits so far?

- Working across sectors / departments
- Bringing different stakeholders together (learning to speak the same language)
- Governance levels finding new ways to collaborate a clear benefit related in particular to the Cities Mission and the national support frameworks being developed across EU

### What should be strengthened?

- Developing and strengthening of skills and competences need for transversal skills
- Synergies and coordination between the missions regions and cities working on multiple missions (no silos)
- Synergies between the Missions and other funding programmes EU programmes, structural funds, RRF, etc.

## **EUROPEAN PARTNERSHIPS**

### Governance

- Having more local and regional actors active in the European Partnerships and their governance structures (all types of partnerships)
- Co-funded partnerships
  - public authorities can easily participate and become full partners
  - Regional authorities can define the eligibility criteria for the funding (e.g. Pays de la Loire, Basque Country in CEPT partnership) > funding put into the partnership comes back to the region. Having multiple agencies involved also makes it possible for different types of actors to be beneficiaries.
  - The ecosystem approach is sometimes lacking as the funding agency involved in the partnership only can fund one type of actor, e.g. universities (e.g. DUT)

### Funding synergies

- Guidance document on synergies is not enough, it also needs to be operationalised
- For the moment structural funds cannot be used as co-funding in co-funded partnerships even if there is a lot of interest to do so

## WIDENING

#### General comments


- Underline the strategic importance of widening (also in the context of the New European Innovation Agenda)
- Widening elements should be included across HE as a cross-cutting element (provide some examples such as the Adaptation Mission demonstration call). However, this should not be too strict learn from programmes such as I3 where too strict rules hinder engagement of certain type of regions
- Widening areas = "Emerging innovators"

### **WIDERA Work Programme**

- What are the main reasons for the low stakeholder engagement from the widening countries in Horizon Europe?
- What type of calls could further encourage widening actors to get engaged and to improve the regional and local R&I capacities?
- As widening and ERA are very different, is combining them in the same work programme the right way forward?
   Recommendations?

### Widening measures (more broadly than WIDERA)

- What support measures would need to be developed (or existing measures revised) to achieve a better impact?
- How to increase knowledge of Horizon Europe and the wider research and innovation policy objectives among the widening





## **ECOSYSTEM APPROACH**

### New European Innovation Agenda

- How will the Innovation Agenda be implemented in the Horizon Europe Strategic Plan?
- Need to integrate the ecosystem approach in the Flagship 3 into the Horizon Europe planning. There is much room to improve further coordination between ecosystem initiatives, connect the dots and bring the various elements together. There is no need to reinvent the wheel, but maybe to articulate and focus certain initiatives better and make them further connected (e.g. regional innovation valleys)
